# **Annual General Meeting 2019**

Held on the 22 September 2019 at Basildon Sporting Village, Cranes Farm Road, Basildon, Essex

The chairman opened the meeting and thanked everyone for coming. The meeting commenced at 10.15.

#### Minutes of previous meeting:

The minutes of the previous AGM had been circulated.

It was proposed by L Wiles, seconded by F Gold that the minutes of the previous meeting were approved. All agreed.

#### **Matters arising:**

There were no matters arising.

# **Treasurer's report:**

A statement of the accounts is attached. A Mullender reported that financially the league was in a good position and that overall there was a small profit this year mainly due to an increase in the door takings at the galas. He stated that there were a few outstanding fines to be paid but this would be discussed later in the meeting. He also stated that the fees and door entrance at galas would remain the same as there was no need to change them. **Andy also reminded all clubs that £50 affiliation fees for the new season are now due**. Harwich and Runnymede were thanked for their payments which had been made prior to the AGM.

The accounts were proposed by S Winnell, seconded by C Adcroft. All agreed.

# **Barking & Dagenham's late withdrawal**

It was explained that even though Barking and Dagenham had been sent fine letters for all the galas they missed as per the ESL rules, none of them have been paid. After some discussion it was agreed that they would be sent a final reminder with a deadline to pay the fines. It was felt that if they didn't still pay that the only other option would be to go through Swim England as per our rules however the committee agreed that it wouldn't be the right thing to do at the present time. Therefore if ever Barking & Dagenham wanted to return to the league, the matter of the unpaid fines would be looked at again before any application would be considered.

### **Review of new ESL format**

It was agreed that the new format was fine although M McPherson (Witham) asked if both the divisions could have the same programme as it was difficult for those clubs that found themselves moving between the two. After some discussion, a revised programme was devised and agreed on to use for both divisions. Events will be as per Division One programme except for a) the 100m Open Fly will now be 50m and b) the 11&U Medley Relay will now operate as 4x1

length. The change of programme was proposed by M McPherson, seconded by S Westwood. 6 agreed and 1 against. Proposal carried.
